1. ORGANIZATION

The selective national Team Race Optimist is organized from April 24th to 26st, 2020 by the Société des Régates d'Antibes in the bay of Antibes.

2. RULES

The regatta will be governed by:

- 2.1 Rules as defined in Racing Rules of Sailing including Appendix D 2017-2020.
- 2.2 National requirements applying to foreign competitors specified in the Annex "Requirements" if necessary
- 2.3 Federal regulations
- 2.4 In case of translation, the French text shall take precedence.

3. ELIGIBILITY AND ENTRY

- 3.1 The selection event is reserved for sailors born from 2005 to 2010. (The french sailors selected for the Worlds and the foreign sailors will participate but will not be eligible for the french selection for the European Team Racing Championship). The teams will be formed freely, without constraint of belonging to a club, League or Zone.
- 3.2 Maximum 24 teams, including a maximum of 12 foreign teams, retained in the order of registration.
For french teams, beyond 12 teams entered, teams aiming for a selection will be priority will have priority.
- 3.3 Composition of the teams
Teams aiming for a selection for France: 2 sailors of one sex and 2 sailors of the other, born from 2005 to 2008, with French license.
Foreign or non-selection teams: free composition of 4 or 5 sailors born from 2005 to 2010
- 3.4 Rotations
Substitutions for non-selection teams will be made between races at the discretion of each team.
- 3.5 Individual french sailors selected for the World Championship will participate in the Team Race without aiming a selection for the Team Racing Europeans.
- 3.6 The team selected at the European Championship will be the highest ranked team of applicant teams to the selection, among all ranked teams.

4. FEES

- 4.1 The registration fee is € 180 per team (with 4 or 5 sailors).
- 4.2 Eligible teams must complete the registration form and return it with the registration fee requested, from February 1st, and no later than April 18th, 2020 at 00:00

- 4.3 At the end of the CIP fleet racing, according to the Worlds selections, french teams aiming at the team selection for the European Team Racing Championship will be allowed to be modified, respecting NoR 3.1 and 3.3
- 4.4 Upon registration, a deposit of 60 € per team will be requested for the management of bibs.

5. QUALIFYING AND FINAL SERIES

The regatta will consist of qualifying series (round robin and/or groups) and final series.

6. PROGRAM

7. RACE FORMAT

- 7.1 Matches are sailed in 4 against 4

7.2 Each team will participate in between 12 and 24 races throughout the National, depending on weather conditions.

10. APPLICATION TO ORGANIZATION

12. Insurance

Sailors with a FFVoile license must be able to present at the time of registration :

- - The 2020 "Competition" type license.
- - If necessary, the authorization for advertising.

Foreign sailors without a FFVoile license must present at the time of registration:

- - Proof of membership of a National Authority member of World Sailing.
- - Valid proof of insurance in civil liability with a minimum cover of two million Euros
- - A medical certificate of no contraindication to the practice of sailing in competition dating

less than a year (written in French or in English).

- - Parental authorization

13. RIGHT TO IMAGE :

By participating in this event, each sailor or his legal representative, tacitly authorizes the organizing authority, the Optimist Promotion, the sponsors of the event and the photographers or cameramen to use and broadcast, without limitation, moving photos or static, racing or ashore, films or television recordings and other reproductions of himself during and after the period of the competition entitled «Team Race CIP Antibes» to which the rider participates in his full agreement. It allows a free exploitation of the said images without any compensation for its right to the image.
